SINOPSIS KURSUS/ COURSE SYNOPSIS

Program Bacelor Ekonomi dengan Kepujian/ Bachelor of Economics with Honours

ECN3010 Prinsip Ekonomi/ *Principles of Economics* 3(3+0)

Prasyarat/ *Prerequisite*: Tiada/ *None*

Kursus ini merangkumi teori asas mikroekonomi dan makroekonomi. Hubungan di antara teori dan isu ekonomi ditekankan.

This course covers the fundamental theories of microeconomics and macroeconomics. The relationship between theories and economic issues are emphasized.

ECN3013 Mikroekonomi/ *Microeconomics* 3(3+0)

Prasyarat/ *Prerequisite*: ECN3010

Kursus ini merangkumi teori mikroekonomi berkenaan gelagat pengguna, firma, dan struktur pasaran. Penekanan diberi kepada analisis isu ekonomi dengan menggunakan kaedah matematik.

This course covers the microeconomics theories related to consumer behavior, firms, and market structure. Emphasis is given to the analysis of economic issues using mathematical methods.

ECN3014 Makroekonomi/ *Macroeconomics* 3(3+0)

Prasyarat/ *Prerequisite*: ECN3010

Kursus ini merangkumi pemahaman asas masalah makroekonomi iaitu penentuan output, pekerjaan, pengangguran, kadar faedah dan inflasi. Dasar kewangan, dasar fiskal, hutang awam dan masalah ekonomi antarabangsa turut ditekankan.

This course offers insights into the understanding of fundamental macroeconomic issues: the determination of output, employment, unemployment, interest rates and inflation. Monetary policy, fiscal policy, public debt and international economic issues is also emphasized.

ECN3015 Mikroekonomi Pertengahan/ *Intermediate Microeconomics* 3(3+0)

Prasyarat/ *Prerequisite*: ECN3013

Kursus ini merangkumi teori mikroekonomi berkaitan dengan pasaran input, analisis keseimbangan umum, kecekapan pasaran dan teori permainan. Masalah yang berkaitan dengan kegagalan pasaran dan keputusan kerajaan yang melibatkan risiko dibincangkan.

This course covers microeconomic theory related to the input market, general equilibrium analysis, market efficiency and game theory. Problems related to market failure and government decisions involving risks are discussed.

ECN3016 Makroekonomi Pertengahan/ *Intermediate Macroeconomics* 3(3+0)

Prasyarat/ *Prerequisite*: ECN3014

Kursus ini merangkumi teori dan isu makroekonomi dalam perubahan struktur ekonomi. Faktor yang mempengaruhi ekonomi tempatan dan luar negara ditekankan. Hubungkait teori makroekonomi dengan masalah dan dasar ekonomi dibincangkan.

This course covers macroeconomic theory and issue in economic structural changes. Factors affecting domestic and foreign economies are emphasized. The relation of macroeconomics theories with problems and policies are discussed.

ECN3111 Sejarah Pemikiran Ekonomi/ *History of Economic Thoughts* 3(3+0)

Prasyarat/ *Prerequisite*: Tiada/ *None*

Kursus ini merangkumi evolusi pemikiran ekonomi yang menumpukan kepada perubahan dalam pemikiran dan dasar ekonomi berkait dengan masalah ekonomi dan sosial.

This course covers the evolution of economic thought which focuses on the changes in economic thought and policy related to economic and social problems.

ECN3112 Pengenalan kepada Ekonomi Islam/ *Introduction to Islamic Economics* 3(3+0)

Prasyarat/ *Prerequisite*: Tiada/ *None*

Kursus ini merangkumi prinsip dan amalan sistem ekonomi Islam. Asas, falsafah dan pembahagian sektor dalam ekonomi Islam ditekankan. Perbandingan di antara kaedah ekonomi konvensional dengan ekonomi Islam juga dibincangkan.

This course covers the principles and practices of Islamic economics. Fundamentals, philosophy and sectoral division in Islamic economics are emphasized. Comparison between conventional economics and Islamic economics is also discussed.

- ECN3113 Ekonomi Malaysia/ *Malaysian Economy* 3(3+0)
 Prasyarat/ *Prerequisite*: Tiada/ *None*
 Kursus ini merangkumi dasar-dasar yang diperkenalkan bagi sektor ekonomi di Malaysia. Perkembangan struktur ekonomi dan isu semasa juga dibincangkan.
This course covers the policies introduced for the economic sector in Malaysia. The development of economic structure and current issues are also discussed.
- ECN3211 Aplikasi Algebra dalam Ekonomi/ *Application of Algebra in Economics* 3(3+0)
 Prasyarat/ *Prerequisite*: Tiada/ *None*
 Kursus ini merangkumi pengenalan kepada konsep dan kaedah algebra yang digunakan dalam bidang ekonomi. Aplikasi kaedah algebra sebagai salah satu pendekatan bagi menyelesaikan masalah ekonomi juga dibincangkan.
This course covers an introduction to the mathematical concepts and methods used in field related to of economics. The application of the algebra methods as one of the approaches to solve economic problems are also discussed.
- ECN3212 Aplikasi Kalkulus dalam Ekonomi/ *Application of Calculus in Economics* 3(3+0)
 Prasyarat/ *Prerequisite*: ECN3211
 Kursus ini merangkumi pengenalan kepada konsep dan kaedah kalkulus yang digunakan dalam bidang ekonomi. Aplikasi kaedah kalkulus sebagai salah satu pendekatan bagi menyelesaikan masalah ekonomi juga dibincangkan.
This course covers an introduction to the mathematical concepts and methods of calculus used in field related to of economics. The application of the calculus methods as one of the approaches to solve economic problems are also discussed.
- ECN3213 Data Analitik dalam Ekonomi/ *Data Analytics in Economics* 3(3+0)
 Prasyarat/ *Prerequisite*: Tiada/ *None*
 Kursus ini merangkumi konsep data, piawaian, kaedah pengiraan dan ilustrasi data ekonomi. Pengendalian dan kaedah manipulasi data untuk analisis ekonomi serta proses mentafsir maklumat bagi pembuatan keputusan berdasarkan data turut dibincangkan.
This course covers concepts of data, standard, estimation technique and economic data illustration. Data handling and data manipulation methods for economic analysis as well as interpretation processes for decision making based on data are discussed.
- ECN3222 Statistik Ekonomi/ *Statistical Economics* 3(3+0)
 Prasyarat/ *Prerequisite*: ECN3213
 Kursus ini merangkumi pengenalan kaedah statistik dalam pembelajaran ekonomi. Pengenalpastian kaedah statistik yang bersesuaian bagi menangani isu ekonomi dan perbincangan hasil analisis diberi penekanan.
This course covers the introduction of statistical methods in the study of economics. The identification of appropriate statistical methods in solving economic issues and the discussion of the analysis findings are emphasized.
- ECN4129 Kaedah Penyelidikan Ekonomi/ *Research Methodology in Economics* 3(3+0)
 Prasyarat/ *Prerequisite*: Tiada/ *None*
 Kursus ini merangkumi kaedah penyelidikan saintifik sebagai satu strategi untuk menyelesaikan isu ekonomi. Sorotan literatur, pembentukan hipotesis dan model, pengumpulan data serta pengukuran empirikal ditekankan.
This course covers the scientific research method as a strategy for addressing an economic issue. Literature review, hypothesis and model formulation, data collection and empirical testing are emphasized.
- ECN4231 Pengenalan kepada Ekonometrik/ *Introduction to Econometrics* 4(3+1)
 Prasyarat/ *Prerequisite*: ECN3222
 Kursus ini merangkumi teori ekonometrik dan teknik statistik untuk menghubungkan kait pelbagai pembolehubah ekonomi. Kaedah penganggaran model ekonomi bagi menyelesaikan masalah ekonomi dibincangkan.

This course covers econometric theory and statistical techniques to relate various economic variables. Methods in estimating economic models in solving economic problems are discussed.

ECN4234 Ekonometrik Gunaan/ *Applied Econometrics* 4(3+1)

Prasyarat/ *Prerequisite*: ECN4231

Kursus ini merangkumi kaedah ekonometrik untuk menganalisis masalah ekonomi di mana ia menumpu kepada perkaitan di antara teori ekonomi dengan teknik anggaran, dan mentafsir hasil dapatan empirik dari pelbagai teknik kuantitatif.

This course covers econometric methods to analyze economic problems in which it focuses on linking economic theory to estimation techniques and interpreting the empirical results of various quantitative techniques.

ECN4235 Analisis Siri Masa dan Unjuran/ *Time Series Analysis and Forecasting* 4(3+1)

Prasyarat/ *Prerequisite*: ECN4231

Kursus ini merangkumi teknik analisis siri masa dan unjuran, termasuk pelbagai model siri masa dan kaedah utama untuk menganalisis model tersebut. Fokus utama adalah memahami kaedah dan menerapkannya ke data sebenar.

The course covers time series analysis and forecasting techniques, which include a variety of models for time series and the main methods for analyzing those models. The main focus is on understanding the methods and applying them to real data.

ECN4261 Penilaian Projek/ *Project Evaluation* 3(3+0)

Prasyarat/ *Prerequisite*: ECN3010

Kursus ini merangkumi teori dan teknik, perhubungan antara perancangan di peringkat mikro dan makro. Teknik penilaian projek, kaedah tradisional dan kaedah pendiskaunan serta isu dalam perancangan dan penilaian projek dibincangkan. Pendekatan matematik dan digital digunakan di dalam menganalisis pelaksanaan projek.

This course includes the theories and techniques, relationship between evaluation techniques; traditional methods and discounting methods and issues in project planning and evaluation are discussed. The application of mathematical and digital approaches is adopted to analyze the implementation of the project.

ECN4263 Ekonomi Eksperimen/ *Experimental Economics* 3(3+0)

Prasyarat/ *Prerequisite*: ECN3013

Kursus ini adalah pengenalan kepada bidang Ekonomi Eksperimen dan kaedahnya. Ia akan memperkenalkan eksperimen yang digunakan dalam Ekonomi untuk menilai teori dan andaian tingkah laku dan mencadangkan dasar ekonomi bagi menyelesaikan masalah ekonomi.

This course is an introduction to the field of Experimental Economics and its methods. It will introduce experiments used in Economics to evaluate theories and assumptions of behaviour and propose economic policies for solving economic problems.

ECN4314 Ekonomi Sumber dan Alam Sekitar/ *Natural Resource and Environmental Economics* 3(3+0)

Prasyarat/ *Prerequisite*: ECN3010

Kursus ini merangkumi teori asas penghausan (depletion), ekonomi kebajikan dan masalah berkaitan dengan kegagalan sistem pasaran untuk memperuntukkan sumber dengan cekap. Isu kecekapan ekonomi ditekankan dalam menganalisis kaedah, membandingkan strategi dan pengaplikasian instrumen bagi mengawal kualiti alam sekitar.

This course covers the basic theory of depletion, welfare economics and the problems associated with the failure of the market system to allocate resources efficiently. The issue of economic efficiency is emphasized in analyzing methods, comparing strategies and application of economic instruments to control the quality of the environment.

ECN4315 Ekonomi Pelancongan dan Rekreasi/ *Tourism and Recreation Economics* 3(3+0)

Prasyarat/ *Prerequisite*: ECN3010

Kursus ini merangkumi teori dan konsep asas ekonomi di dalam penilaian faedah dan kos rekreasi dan ekopelancongan. Kesejahteraan individual dan komuniti serta kemampunan alam semulajadi dibincangkan. Penekanan diberi kepada pembuatan keputusan dengan mengaplikasi teknik penilaian sumber rekreasi dan ekopelancongan.

This course covers the basic theories and concepts of economics in the valuation of the benefits and costs of recreation and ecotourism. Individual and community well-being as well as natural sustainability are discussed. Emphasis is placed on decision making by applying recreational and ecotourism resource valuation techniques.

ECN4410 Wang, Institusi Kewangan dan Perbankan/ Money, Financial Institutions and Banking 3(3+0)

Prasyarat/ Prerequisite: ECN3014

Kursus ini merangkumi analisis wang, penentuan kadar faedah, fungsi bank perdagangan dan bank pusat serta bagaimana maklumat asimetri dan dasar kerajaan membentuk evolusi mereka. Kesan wang dan dasar kewangan bank pusat di era digital juga dibincangkan.

This course covers analysis of money, the determination of interest rate, the roles of commercial banks and central bank as well as how information asymmetries and regulation have shaped their evolution. The impact of money and monetary policy in the digital era are also discussed.

ECN4411 Ekonomi Kewangan/ Financial Economics 3(3+0)

Prasyarat/ Prerequisite: ECN3014

Kursus ini merangkumi aspek ekonomi, kewangan dan pengurusan pelaburan. Hipotesis kecekapan pasaran, gelagat kewangan, kewangan digital, pembangunan pasaran dan penentu pembangunan kewangan ditekankan.

This course covers the aspects of economics, finance and investment management. The efficient market hypothesis, behavioural finance, digital finance, financial market development and the determinants of financial development are emphasized.

ECN4511 Ekonomi Perindustrian / Industrial Economics 3(3+0)

Prasyarat/ Prerequisite: ECN3013

Kursus ini merangkumi organisasi dan operasi firma dalam industri persaingan sempurna dan tidak sempurna. Penekanan diberikan terhadap model struktur pasaran, gelagat dan prestasi serta kemajuan teknologi dan akta persaingan.

This course covers organization and firms' operation in the perfect and imperfect competitive industries. Emphasis will be given on the model of market structure, conduct and performance (SCP) as well as technology advancement and competition acts.

ECN4514 Ekonomi Strategi/ Strategy of Economics 3(3+0)

Prasyarat/ Prerequisite: ECN3013

Kursus ini merangkumi teori ekonomi dalam membuat keputusan strategi perniagaan. Hubungkait antara konsep asas mikroekonomi, pendekatan pasaran dalam ekonomi dengan strategi perniagaan ditekankan.

This course covers the economic theory for strategic business decision. The relationship among microeconomics basic concepts, economic approaches in markets and business strategy is emphasized.

ECN4611 Ekonomi Pembangunan/ Economic Development 3(3+0)

Prasyarat/ Prerequisite: ECN3014

Kursus ini merangkumi konsep, teori dan dasar pembangunan ekonomi. Petunjuk ekonomi dan sosial digunakan untuk mengukur dan memberi cadangan penyelesaian kepada masalah pembangunan ekonomi.

This course covers the concepts, theories and policies for economic development. Economic and social indicators are used to measure and provide solution to the problems of economic development.

ECN4613 Ekonomi Buruh/ Labour Economics 3(3+0)

Prasyarat/ Prerequisite: ECN3013

Kursus ini merangkumi konsep ekonomi buruh dan isu berkaitan dengan buruh. Hubungkait teori dengan polisi berkaitan dengan buruh ditekankan untuk memahami pasaran buruh.

This course covers the concepts of labour economics and issue related to labour. The relationship between theories and policies of labours are emphasised to understand the labour market.

- ECN4615 Ekonomi Wilayah/ *Regional Economics* 3(3+0)
 Prasyarat/ *Prerequisite*: ECN3013
 Kursus ini merangkumi asas teori dan aplikasi empirikal dalam bidang pembangunan ekonomi wilayah. Penekanan diberi kepada kaedah analisis masalah ekonomi wilayah berkaitan ekonomi sosial dan alam sekitar.
This course covers theoretical foundations and empirical applications in the field of regional economics. Emphasis is given to the techniques to analyse regional economic problems related to economic, social and environment.
- ECN4617 Ekonomi Kesihatan/ *Health Economics* 3(3+0)
 Prasyarat/ *Prerequisite*: ECN3013
 Kursus ini merangkumi konsep ekonomi dalam menganalisis pasaran penjagaan kesihatan. Kursus juga menghubungkan kaitkan teori di dalam bidang ekonomi di dalam sektor penjagaan kesihatan. Kegagalan pasaran dan dasar kerajaan dalam pasaran penjagaan kesihatan ditekankan.
This course covers economic theory in analyzing the healthcare market. The course is also relate theories in economic fields in healthcare sectors. Market failures and government policies in the healthcare market are emphasized.
- ECN4619 Ekonomi Politik/ *Political Economics* 3(3+0)
 Prasyarat/ *Prerequisite*: ECN3014
 Kursus ini merangkumi teori dan isu semasa berkenaan hubungan politik dan ekonomi. Penekanan diberikan terhadap masalah ekonomi politik di peringkat nasional dan antarabangsa.
This course covers theory, and current issues of the intersection between politics and economics. Emphasis are given on the problems in political economic issues at both domestic and international levels.
- ECN4620 Ekonomi Digital/ *Digital Economics* 3(3+0)
 Prasyarat/ *Prerequisite*: Tiada/ *None*
 Kursus ini merangkumi konsep dan teori ekonomi digital. Penekanan diberikan kepada aplikasi digital dalam aktiviti ekonomi terutama didalam pasaran buruh dan kewangan serta cabaran dan implikasinya ke atas ekonomi global.
This course covers the concepts and theories of digital economics. Emphasis is given on digital applications in economic activities especially in labour and finance market as well as the challenges and implications for the global economy.
- ECN4711 Pembiayaan Awam / *Public Finance* 3(3+0)
 Prasyarat/ *Prerequisite*: ECN3014
 Kursus ini merangkumi peranan kerajaan di dalam ekonomi negara. Analisis isu dasar awam secara teoritikal dan empirikal ditekankan. Kecekapan pengagihan sumber awam, percukaian dan perbelanjaan kerajaan di dalam struktur fiskal persekutuan dibincangkan.
This course encompasses the role of government in the economy. Analyses of public policy issues theoretically and empirically are emphasized. Efficient allocation of public resources, taxation and government expenditure in the fiscal federalism structure are discussed.
- ECN4713 Pembuatan Keputusan dan Dasar Awam/ *Decision Making and Public Policy* 3(3+0)
 Prasyarat/ *Prerequisite*: ECN3014
 Kursus ini merangkumi pengenalan kepada konsep dasar awam dan kaedah pembuatan keputusan yang digunakan dalam bidang ekonomi. Penekanan diberikan untuk mengenal pasti masalah ekonomi semasa dan pencarian penyelesaian.
This course introduces the concept of public policy and decision-making methods in the field of economics. Emphasis will be given on identifying and solving current economic problems.
- ECN4812 Perdagangan Antarabangsa/ *International Trade* 3(3+0)
 Prasyarat/ *Prerequisite*: ECN3013
 Kursus ini merangkumi teori dan dasar perdagangan antarabangsa. Teori moden berkaitan dengan perdagangan intra industri, halangan perdagangan dan perjanjian perdagangan bebas ditekankan.
This course covers the international trade theories and policies. Modern theories related to intra industry trade, trade barriers and free trade agreements are emphasized.

- ECN4813 Kewangan Antarabangsa/ *International Finance* 3(3+0)
 Prasyarat/ *Prerequisite*: ECN3014
 Kursus ini membincangkan teori dan isu kewangan antarabangsa termasuk imbangan pembayaran, pasaran tukaran asing dan mata wang digital serta kesannya ke atas ekonomi negara.
This course discusses theories and issues in international finance including balance of payments, foreign exchange market and digital currency as well as its impact on the national economy.
- ECN4815 Integrasi Ekonomi/ *Economics Integration* 3(3+0)
 Prasyarat/ *Prerequisite*: ECN3014
 Kursus ini merangkumi teori dan kriteria penubuhan kesatuan ekonomi dan kesatuan monetari. Analisis kesatuan ekonomi semasa dan proses pengharmonian dasar kesatuan ekonomi dibincangkan.
This course covers theories and criteria for the formation of economic unions and monetary unions. The analysis of the current economic union and the harmonization process of policies in an economic union are discussed.
- ECN4903 Latihan Industri / *Industrial Training* 8(0+8)
 Prasyarat/ *Prerequisite*: ECN4959
 Kursus ini merangkumi pendedahan kepada persekitaran kerja sebenar di industri. Latihan meliputi aplikasi teori dan praktikal yang telah dipelajari dengan amalan semasa di tempat kerja. Kemahiran komunikasi dan menyelesaikan masalah turut diberi penekanan.
This course covers exposure to the actual work environment in the industry. The training covers the theoretical and practical applications that have been learned with current practice in the workplace. Communication and problem solving skills are also emphasized.
- ECN4959 Disertasi Bachelo/ *Bachelor Dissertation* 6(0+6)
 (A & B)
 Prasyarat/ *Prerequisite*: ECN4129
 Kursus ini merangkumi penyediaan cadangan, pelaksanaan dan penulisan saintifik untuk projek penyelidikan ekonomi. Pendekatan saintifik bagi menjana data secara sistematik melalui rekabentuk, pengumpulan dan analisis data yang sesuai diberi penekanan.
This course covers the preparation of proposal, implementation and scientific writing of research project in economics. Scientific approach to generate data systematically through appropriate design, data collection and analysis are emphasized.

Bachelor Perakaunan (Kepujian) / Bachelor of Accounting (Honours)

- ACN3101 Maklumat Perakaunan dan Kewangan / *Accounting and Financial Information* 3(3+0)
Prasyarat/ *Prerequisite*: Tiada/ *None*
Kursus ini merangkumi konsep asas perakaunan, penyediaan penyata kewangan perniagaan milikan tunggal dan penggunaan maklumat perakaunan dalam perniagaan.
This course covers fundamental concepts of accounting, preparation of financial statements of sole proprietorship and the use of accounting information in business.
- ACN3102 Perakaunan Pengenalan/ *Introductory Accounting* 3(3+0)
Prasyarat/ *Prerequisite*: Tiada/ *None*
Kursus ini merangkumi perkara asas mengenai maklumat perakaunan dalam pembuatan keputusan dan penyediaan penyata kewangan. Kursus ini juga membincangkan tentang analisis dan interpretasi penyata kewangan perniagaan.
This course covers the basic elements of accounting for decision making and preparation of financial statements. This course also discusses the analysis and interpretation of business financial statements.
- ACN3111 Pengenalan Kepada Perakaunan Kewangan dan Pelaporan/ *Introduction to Financial Accounting and Reporting* 3(3+0)
Prasyarat/ *Prerequisite*: Tiada/ *None*
Kursus ini merangkumi asas perakaunan dan pelaporan maklumat kewangan dalam organisasi perniagaan. Penekanan diberikan kepada pemahaman teknik perakaunan dan perekodan prosedur secara manual dan berkomputer.
This course covers the basics of accounting and the reporting of financial information in business organizations. Emphasis is given to the understanding of accounting techniques and recording procedures manually or using computer.
- ACN3112 Perakaunan Kewangan dan Pelaporan Pertengahan I/ *Intermediate Financial Accounting and Reporting I* 3(3+0)
Prasyarat/ *Prerequisite*: ACN3111
Kursus ini merangkumi perakaunan bagi aset, hasil dan ekuiti tertentu mengikut kerangka pelaporan kewangan semasa untuk penyediaan laporan kewangan perkongsian dan syarikat. Kaedah analisis kewangan terpilih digunakan untuk menilai prestasi dan kedudukan kewangan entiti pelapor.
This course covers accounting for assets, revenues and specific equities in compliance with the current reporting framework for the preparation of partnership and company's financial report. Selected financial analysis methods are used to assess reporting entity's financial performance and position.
- ACN3113 Perakaunan dan Pelaporan Kewangan Pertengahan II/ *Intermediate Financial Accounting and Reporting II* 3(3+0)
Prasyarat/ *Prerequisite*: ACN3112
Kursus ini merangkumi perakaunan untuk aset, liabiliti, pendapatan, belanja dan ekuiti untuk industri terpilih mengikut kerangka pelaporan kewangan semasa secara beretika. Perkembangan isu semasa juga diambil kira dalam penyediaan laporan kewangan.
This course covers accounting for assets, liabilities, income, expenses and equities for selected industries in compliance with current reporting framework. Development in current issues are taken into consideration for the preparation and assessment of company's financial report.
- ACN4111 Perakaunan Kewangan dan Pelaporan Lanjutan I/ *Advanced Financial Accounting and Reporting I* 3(3+0)
Prasyarat/ *Prerequisite*: ACN3113
Kursus ini merangkumi isu perakaunan lanjutan untuk aset dan liabiliti berdasarkan kerangka pelaporan kewangan. Ia memberi pengenalan kepada perakaunan kumpulan syarikat, bersekutu dan pengaturan bersama serta menekankan pembuatan keputusan yang beretika.

This course covers advanced accounting issues for assets and liabilities based on financial reporting framework. It gives an introduction to accounting for group accounts, associate and joint arrangement as well as emphasising ethical decision making.

ACN4112 Perakaunan Kewangan dan Pelaporan Lanjutan II/ *Advanced Financial Accounting and Reporting II* 3(3+0)

Prasyarat/ *Prerequisite*: ACN4111

Kursus ini merangkumi isu pelaporan kewangan lanjutan untuk aset, liabiliti, ekuiti, pendapatan dan belanja. Ia juga membincangkan penyediaan penyata kewangan disatukan untuk struktur kumpulan yang kompleks dan pembuatan keputusan secara beretika.

This course covers advanced financial reporting issues for assets, liabilities, equities, income and expenses. It also discusses the preparation of consolidated financial statements for complex group structure and ethical decision making.

ACN4121 Teori dan Isu Dalam Perakaunan/ *Theory and Issues in Accounting* 3(3+0)

Prasyarat/ *Prerequisite*: ACN4112

Kursus ini merangkumi perbincangan sejarah dan pembangunan teori serta persekitaran perakaunan. Ianya juga membincangkan isu semasa berkaitan pelaporan kewangan, isu perakaunan global dan amalan perakaunan terkini.

This course covers discussion on history and theory development as well as accounting environment. It also discusses current issues on financial reporting, global accounting issues and the current accounting practice.

ACN3211 Perakaunan Pengurusan I/ *Management Accounting I* 3(3+0)

Prasyarat/ *Prerequisite*: ACN3111

Kursus ini merangkumi konsep kos, teknik pengekosan serta penggunaan maklumat perakaunan pengurusan untuk membuat keputusan perancangan dan kawalan.

This course covers cost concepts, costing techniques and the use of management accounting information for planning and control decisions.

ACN3212 Perakaunan Pengurusan II/ *Management Accounting II* 3(3+0)

Prasyarat/ *Prerequisite*: ACN3211

Kursus ini merangkumi pembelanjawan, pengekosan piawai dan pengekosan relevan dalam perancangan dan kawalan organisasi. Ia juga termasuk peranan maklumat perakaunan untuk penilaian prestasi dalam firma terpecah dan letak harga pindahan dalam organisasi berbahagian.

This course covers budgeting, standard costing and relevant costing in the planning and control of organisations. It also includes the role of accounting information for performance evaluation in decentralised firms and transfer pricing in divisionalised organisations.

ACN4211 Perakaunan Pengurusan Lanjutan/ *Advanced Management Accounting* 3(3+0)

Prasyarat/ *Prerequisite*: ACN3212

Kursus ini merangkumi teknik pengurusan strategik, pengurusan kos kualiti dan perakaunan pengurusan alam sekitar. Ia juga termasuk teknik berasaskan kos untuk membuat keputusan dan pengukuran prestasi.

This course covers strategic management techniques, quality cost management and environmental management accounting. It also includes cost-based techniques for decision making and performance measurement.

ACN3311 Audit I/ *Audit I* 3(3+0)

Prasyarat/ *Prerequisite*: ACN3112

Kursus ini merangkumi konsep asas pengauditan dan menghubungkan konsep audit dan amalan pengauditan. Penekanan diberikan kepada tanggungjawab profesional oleh juruaudit dan proses pembuatan keputusan yang perlu dilalui oleh juruaudit selari dengan keperluan profesional semasa dan perundangan.

This course covers the basic concepts of auditing and relates the concepts to auditing practices. Emphasis is given to the professional responsibilities of the independent auditor and the decision-making process that the auditor has to go through consistent with the current professional and statutory requirements.

ACN3312 Audit II/ Audit II 3(3+0)

Prasyarat/ Prerequisite: ACN3311

Kursus ini merangkumi aspek kepentingan etika profesional dan keperluan kepatuhan berdasarkan piawaian untuk menyempurnakan audit dengan mengambil kira implikasi peristiwa yang berlaku sebelum laporan audit ditandatangani. Ianya juga memberi pendedahan kepada jenis perkhidmatan lain yang ditawarkan dan isu semasa profesion audit.

This course covers the aspects on the importance of professional ethics and the need to adhere to the standard in completing the audit, taking into consideration the implication of subsequent events before the signage of the audit report. It also provides exposure to the other types of services offered and current issues in audit profesion.

ACN3411 Percukaian I / Taxation I 3(3+0)

Prasyarat/ Prerequisite: ACN3111

Kursus ini merangkumi pentadbiran sistem percukaian di Malaysia dan pengiraan elaun modal. Ianya juga termasuk pengiraan pendapatan kena cukai dan cukai kena bayar oleh pembayar cukai individu. *The course covers the administration of Malaysian taxation system and the calculation of capital allowance. It also includes the computation of chargeable income and income tax payable by individual taxpayer.*

ACN3412 Percukaian II / Taxation II 3(3+0)

Prasyarat/ Prerequisite: ACN3411

Kursus ini merangkumi layanan cukai ke atas perniagaan perkongsian dan syarikat serta mengira pelbagai jenis elaun modal dan insentif untuk perniagaan. Kursus ini juga menekankan layanan cukai ke atas pelupusan hartanah dan skop cukai tidak langsung.

The course covers tax treatment on income from partnership business and corporation as well as computation of various types of capital allowance and company incentives. It also focuses on tax treatment on disposal of real property and the scope of indirect taxes.

ACN3511 Sistem Maklumat Perakaunan dan Kawalan Dalam/ Accounting Information System and Internal Control 3(3+0)

Prasyarat/ Prerequisite: ACN3111

Kursus ini merangkumi komponen sistem maklumat perakaunan dan prosedur kawalan dalaman dalam proses menyediakan maklumat perakaunan yang berkualiti dan beretika. Penekanan juga diberikan dalam menganalisis pakej perakaunan berkomputer yang bersesuaian bagi menyediakan penyata kewangan syarikat.

This course covers the components of accounting information systems and internal control procedures in the process of providing a quality and an ethical accounting information. Emphasis is also given in analysing the suitable computerized accounting package for the preparation of the organization's financial statement.

ACN4521 Rekabentuk dan Pembangunan Sistem Maklumat Perakaunan/ Accounting Information System Design and Development 3(3+0)

Prasyarat/ Prerequisite: ACN3511

Kursus ini merangkumi pelbagai pendekatan pembangunan sistem maklumat perakaunan dan perbincangan terperinci fasa kitaran hayat pembangunan sistem. Kursus ini juga mendedahkan perkembangan teknologi terkini dan kesannya ke atas pembangunan sistem.

This course covers the various approaches of accounting information system development and detail discussion on the phases of systems development life cycle. This course exposes the latest technology advancements and their implications on system development.

- ACN4711 Etika Perniagaan dan Takbir Urus Korporat/ *Business Ethics and Corporate Governance* 3(3+0)
 Prasyarat/ *Prerequisite*: ACN3312
 Kursus ini merangkumi teori dan falsafah etika dalam individu dan hubungannya dengan organisasi korporat. Kursus ini juga mendedahkan pelajar kepada perkembangan semasa isu etika dan tadbir urus korporat dalam persekitaran perniagaan.
This course covers theories and philosophies of ethics in individuals and their relation with corporate organizations. This course also exposes students to current ethical and corporate governance issues in business environment.
- ACN4712 Kajian Kes Bersepadu/ *Integrated Case Study* 3(3+0)
 Prasyarat/ *Prerequisite*: ACN3312, ACN4211 & MGM4139
 Kursus ini merangkumi pengetahuan dari pelbagai bidang perakaunan dan pengurusan yang berkaitan dengan organisasi perniagaan. Penekanan diberikan kepada kemampuan pelajar untuk menganalisis, menyelesaikan masalah dan membuat keputusan yang beretika dalam konteks persekitaran perniagaan dan komuniti.
This course covers knowledge from various aspects of accounting and management in relation to business organization. Emphasis is given to the ability of students to analyze, solve problems and make ethical decisions in the context of the business environment and community.
- ACN4901 Latihan Industri/ *Industrial Training* 12(0+12)
 Prasyarat/ *Prerequisite*: ACN4111, ACN3211, ACN3311 & ACN3412
 Kursus ini melibatkan penempatan pelajar dalam firma audit atau firma yang dibenarkan oleh fakulti selama enam bulan untuk membiasakan mereka dengan persekitaran kerja yang sebenar, mengaplikasi pengetahuan yang diperolehi semasa kuliah kepada praktis dan meningkatkan kemahiran insaniah.
This course involves a six-month industrial placement of students in an audit firm or firm approved by the faculty to enable them to familiarize with actual working environment, apply knowledge acquired in classroom to practice and enhance soft skills.
- ACN3611 Perakaunan Sektor Awam/ *Public Sector Accounting* 3(3+0)
 Prasyarat/ *Prerequisite*: ACN4111
 Kursus ini merangkumi konsep, peruntukan kewangan dan amalan perakaunan sektor awam. Ia juga menekankan akauntabiliti dan etika dalam perakaunan pengurusan, pengauditan, perakaunan kewangan dan pelaporan.
This course covers the concepts, financial provisions and practices of accounting in public sector. It also emphasises the accountability and ethics in management accounting, auditing, financial accounting and reporting.
- ACN3711 Perakaunan untuk Transaksi Kewangan Islam/ *Accounting for Islamic Financial Transactions* 3(3+0)
 Prasyarat/ *Prerequisite*: ACN3112 & FIN3111
 Kursus ini merangkumi konsep kewangan Islam berdasarkan shariah dan kesannya ke atas transaksi kontrak kewangan. Kursus ini juga memperkenalkan sistem kewangan dan kerangka perakaunan untuk institusi yang menawarkan kontrak kewangan Islam.
This course covers the concept of Islamic finance based on shariah and its impact on financial transaction contracts. This course introduces financial system and accounting framework for institutions offering Islamic financial contracts.
- ACN4131 Perakaunan Terkhusus/ *Specialised Accounting* 3(3+0)
 Prasyarat/ *Prerequisite*: ACN4211
 Kursus ini merangkumi perakaunan yang berkaitan dengan industri terkhusus seperti pembangunan hartanah, pelaburan hartanah, institusi kewangan, insuran, saham amanah, instrumen kewangan, perladangan, pertanian, akuakultur dan industri ekstraktif. Ia juga membincangkan isu-isu semasa pelaporan tentang industri ini. Selain itu, kursus ini juga menilai kualiti amalan pelaporan semasa untuk penambahbaikan pendedahan maklumat perniagaan.

This course covers accounting for specialized industries such as property development, investment property, financial institution, insurance, unit trust, financial instruments, agriculture, and extractive industries. It also discusses the current reporting issues in these industries. Besides that, the course also assesses the quality of current reporting practices to enhance business information disclosure.

ACN4132 Perakaunan Antarabangsa/ *International Accounting* 3(3+0)

Prasyarat/ *Prerequisite*: ACN4112

Kursus ini merangkumi perbincangan tentang pelaporan kewangan, audit, percukaian, perakaunan pengurusan dan pengurusan kewangan di peringkat antarabangsa. Ia juga membincangkan tentang penyatuan pelaporan kewangan dan perbandingan pelaporan beberapa negara terpilih.

This course covers discussion on financial reporting, audit, tax, management accounting and financial management at international level. It also discusses harmonization of financial reporting and comparative reporting in selected countries.

ACN4411 Percukaian Terkhusus/ *Specialised Taxation* 3(3+0)

Prasyarat/ *Prerequisite*: ACN3412

Kursus ini merangkumi pengiraan cukai kena bayar dan isu percukaian bagi industri terkhusus. Ia juga meliputi perancangan cukai secara beretika, pengauditan cukai dan penyiasatan cukai.

This course covers computation of tax payable and tax issues for specialised industries. It also covers ethical tax planning, tax audit and tax investigation.

ACN4713 Kaedah Penyelidikan Perakaunan dan Kewangan/ *Research Methods in Accounting and Finance* 3(3+0)

Prasyarat/ *Prerequisite*: FIN3511/ ACN3112

Kursus ini merangkumi falsafah asas penyelidikan, konsep asas penyelidikan serta tujuan dan kepentingan penyelidikan. Kursus ini juga membincangkan langkah penyediaan cadangan penyelidikan dan kepentingan etika dan ketelusan dalam penyediaan laporan penyelidikan.

This course covers the fundamental philosophy of research, basic concepts and the purposes and importance of research. This course also discusses the steps on preparation of research proposals and the importance of ethics and transparency in the preparation of research report.

ACN4959 Disertasi Bachelior/ *Bachelor Dissertation* 3(0+3)

Prasyarat/ *Prerequisite*: ACN4713

Kursus ini merangkumi penghasilan disertasi bachelior berdasarkan penyelidikan dalam bidang perakaunan dan kewangan. Ianya juga melibatkan pengumpulan, analisis, dan interpretasi data serta pembentangan hasil penyelidikan.

This course covers the production of a bachelor dissertation based on research related to accounting and finance. It involves data collection, analysis, interpretation, and presentation of research findings.

Bachelor Pentadbiran Perniagaan dengan Kepujian/ Bachelor of Business Administration with Honours

MGM3101 Prinsip Pengurusan/ *Principles of Management* 3(3+0)

Prasyarat/ *Prerequisite*: Tiada/ *None*

Kursus ini merangkumi teori, prinsip dan kaedah asas pengurusan. Fungsi pengurusan perniagaan dan organisasi bukan berasaskan keuntungan diberi penekanan.

This course covers the basic theories, principles and tools of management. Management functions related to businesses and non-profit organisations are emphasised.

MGM3111 Komunikasi Pentadbiran dan Perniagaan/ *Business and Administrative Communication* 3(3+0)

Prasyarat/ *Prerequisite*: MGM3101

Kursus ini meliputi fungsi dan kepentingan berkomunikasi. Aplikasi strategi dan teknik berkomunikasi yang berkesan untuk mencapai matlamat organisasi dan perniagaan diberi penekanan.

This course covers the functions and importance of communication. The application of effective communication techniques and strategies for achieving organisational and business goals are emphasised.

MGM3113 Gelagat Organisasi/ *Organizational Behavior* 3(3+0)

Prasyarat/ *Prerequisite*: MGM3101

Kursus ini merangkumi konsep berkaitan gelagat kerja individu, kumpulan dan organisasi. Kesan faktor tersebut ke atas keberkesanan organisasi diberi penekanan.

The course covers concepts related to individual, group and organisational behaviour. The effects of these factors on organisational effectiveness are emphasised.

MGM3123 Pengurusan Sumber Manusia/ *Human Resource Management* 3(3+0)

Prasyarat/ *Prerequisite*: MGM3101

Kursus ini merangkumi konsep pengurusan sumber manusia untuk mengekalkan kelebihan bersaing sesebuah organisasi. Pengaruh faktor dalaman dan luaran dalam pengurusan sumber manusia turut diberi penekanan.

The course covers the human resource concepts to retain the competitive advantages of the organisation. The influence of internal and external factors on human resource management is emphasised.

MGM3165 Analitik Perniagaan/ *Business Analitic* 3(3+0)

Prasyarat/ *Prerequisite*: Tiada/ *None*

Kursus ini membincangkan proses dalam penyelesaian masalah perniagaan dengan menggunakan kaedah kuantitatif. Teknik permodelan matematik dalam pembuatan keputusan perniagaan yang optimal diberi penekanan.

This course discusses the process in the solving of business problems using quantitative methods. Mathematic modelling techniques for optimal business decision making are emphasised.

MGM3180 Asas Keusahawanan/ *Basic Entrepreneurship* 3(3+0)

Prasyarat/ *Prerequisite*: Tiada/ *None*

Kursus ini merangkumi komponen utama dalam aspek perniagaan yang melibatkan perancangan perniagaan berskala kecil. Kompetensi dan pengetahuan keusahawanan diberi penekanan.

This course covers the key components of the business aspects involving planning for small-scale businesses. Entrepreneurial competencies and knowledge are emphasised.

MGM3211 Prinsip Pemasaran/ *Principles of Marketing* 3(3+0)

Prasyarat/ *Prerequisite*: Tiada/ *None*

Kursus ini merangkumi pendekatan pengurusan dalam memahami pembuatan keputusan pemasaran. Pembangunan campuran pemasaran dan strategi pemasaran diberi penekanan.

This course covers the managerial approach in understanding marketing decision making. Developing the marketing mix and marketing strategies are emphasised

- MGM4244 Gelagat Pengguna/ *Consumer Behaviour* 3(3+0)
 Prasyarat/ *Prerequisite*: MGM3211
 Kursus ini merangkumi faktor yang mempengaruhi gelagat pembelian pengguna. Aplikasi amalan dan pembuatan keputusan pengguna diberi penekanan.
This course encompasses factors that influence consumer purchasing behaviour. Application of the practices and decision making of consumers are emphasised.
- MGM3352 Undang-Undang Perniagaan/ *Business Law* 3(3+0)
 Prasyarat/ *Prerequisite*: Tiada/ *None*
 Kursus ini merangkumi sistem perundangan yang mentadbir pelbagai kontrak secara menyeluruh. Status kontrak dan kesan pelaksanaan undang-undang ke atas perniagaan dan pihak berkontrak dalam penentuan kesahan perjanjian adalah diberi penekanan.
This course covers the legal system that governs various contracts as a whole. The status of the contract and the effect of law enforcement on the business and the contracting parties in determining the validity of an agreement are emphasised.
- MGM4106 Kaedah Penyelidikan Perniagaan/ *Business Research Methods* 3(3+0)
 Prasyarat/ *Prerequisite*: MGM3165
 Kursus ini merangkumi langkah-langkah dalam proses penyelidikan. Pernyataan masalah, sorotan karya, metodologi kajian, analisis dan tafsiran data adalah diberi penekanan.
This course covers steps in a research process. Problem statement, literature review, research methodology, data analysis and data interpretation are emphasised.
- MGM4124 Pengurusan Latihan dan Pembangunan/ *Training and Development Management* 3(3+0)
 Prasyarat/ *Prerequisite*: MGM3123
 Kursus ini merangkumi struktur dan proses dalam mereka bentuk program latihan dan pembangunan dalam organisasi. Kaedah yang bersesuaian untuk melatih dan membangunkan pekerja diberi penekanan.
The course covers the structure and process in designing training and development programs within an organisation. Appropriate methods to train and develop employees are emphasised.
- MGM4125 Pengurusan Pampasan/ *Compensation Management* 3(3+0)
 Prasyarat/ *Prerequisite*: MGM3123
 Kursus ini membincangkan faktor dan langkah yang diperlukan dalam mereka bentuk strategi pampasan yang berkesan dalam organisasi. Aktiviti menilai dan mengurus program pampasan bagi menyokong pencapaian matlamat organisasi diberi penekanan.
The course discusses factors and steps required when designing effective strategic compensation for organisations. Evaluating and managing compensation program activities to support the achievement of organisation goals are emphasised.)
- MGM4126 Perhubungan Perusahaan/ *Industrial Relations* 3(3+0)
 Prasyarat/ *Prerequisite*: MGM3123
 Kursus ini merangkumi isu pengurusan perhubungan perusahaan yang melibatkan majikan, pekerja dan kesatuan sekerja. Aspek membina keharmonian perhubungan perusahaan serta peranan majikan dalam mengelak pertikaian diberi penekanan.
This course encompasses issues within industrial relations management that involves employer, employees and the trade union. Aspects in establishing harmonious industrial relations and the roles of employers in avoiding disputes are emphasised.
- MGM4127 Pengambilan dan Pemilihan Pekerja/ *Employee Recruitment and Selection* 3(3+0)
 Prasyarat/ *Prerequisite*: MGM3123
 Kursus ini merangkumi sumber, kaedah dan proses pengambilan dan pemilihan pekerja. Aspek pengambilan dan pemilihan pekerja yang tepat untuk mencapai matlamat organisasi diberi penekanan.
The course encompasses the sources, methods and processes involved in employee recruitment and selection. Aspects on recruiting and selecting the right person to achieve organisation goals are emphasised.

- MGM4129 Pembangunan Organisasi/ *Organization Development* 3(3+0)
 Prasyarat/ *Prerequisite*: MGM3123
 Kursus ini merangkumi strategi pembangunan organisasi untuk peningkatan prestasi individu, kumpulan dan organisasi. Langkah dalam proses perubahan terancang organisasi diberi penekanan.
This course covers organisation development strategies to increase individual, group and organisational performance. Steps in the organisation's process of planned change are emphasised.
- MGM4130 Pengurusan Tempat Kerja Dan Pekerjaan Strategik/ *Strategic Employment and Workplace Management* 3(3+0)
 Prasyarat/ *Prerequisite*: MGM3123

This course covers concepts, theories and strategies in branding management. The importance and current issues in brand management and marketing in a business organisation are emphasised.)

- MGM4297 Pengurusan Produk Baharu/ *New Product Management* 3(3+0)
 Prasyarat/ *Prerequisite*: MGM3211
 Kursus ini merangkumi konsep, teori dan strategi dalam pengurusan produk baharu. Perancangan, pelaksanaan dan pengawalan pengurusan produk baharu dalam sesebuah organisasi perniagaan diberi penekanan.
This course covers concepts, theories and strategies in new product management. The planning, implementation and controlling of new product management in a business organisation are emphasised.
- MGM4321 Undang-undang Syarikat/ *Company Law* 3(3+0)
 Prasyarat/ *Prerequisite*: MGM3352

This course covers the concept of time value of money, risk and return on investment. It also emphasised on the preparation of capital budgeting for efficient and more organized corporate financial planning.

FIN3102 Statistik untuk Kewangan/ *Statistics for Finance* 3(3+0)

Prasyarat/ *Prerequisite*: Tiada/ *None*

This course covers the quantitative methods of statistics by using related statistical software. In addition, the interpretation of the findings is also emphasized.

Prasyarat/ *Prerequisite*: FIN3101

This course covers sources of financing in business venture and evaluates the entrepreneurial firms with business evaluation methods. Strategies in obtaining capital for businesses are emphasised.

This course covers planning and managing of personal finance to enhance decision making capability. Financial planning strategies and type of investments are emphasised.

Prasyarat/ *Prerequisite*: FIN3102

Kursus ini merangkumi falsafah asas penyelidikan, konsep asas penyelidikan serta tujuan dan kepentingan penyelidikan. Kursus ini juga membincangkan langkah penyediaan cadangan penyelidikan dan kepentingan etika dan ketelusan dalam penyediaan laporan penyelidikan.

This course covers the fundamental philosophy of research, basic concepts and the purposes and importance of research. This course also discusses the steps on preparation of research proposals and the importance of ethics and transparency in the preparation of research report.

FIN4101 Kewangan Perbadanan/ *Corporate Finance* 3(3+0)

Prasyarat/ *Prerequisite*: FIN3101

This course covers theories and applications in evaluating and assessing capital budgeting in corporate finance. It also include capital structure, dividends, mergers and acquisitions and risk management.

 Prasyarat/ *Prerequisite*: FIN3101

This course analyzes and evaluates corporate financial and accounting statements. Return on investment, profitability and credit analysis are also emphasised.
- FIN4202 Analisis Pelaburan/ *Investment Analysis* 3(3+0)
 Prasyarat/ *Prerequisite*: FIN3101

This course covers the production of a bachelor dissertation based on research related to finance. It involves data collection, analysis, interpretation, and presentation of research findings.
- FIN4102 Teori dan Polisi Kewangan/ *Finance Theory and Policy* 3(3+0)
 Prasyarat/ *Prerequisite*: Tiada/ *None*

This course discusses finance theories in firms' financial management activities. Application of theories in finance decision making process is emphasised.
- FIN4103 Kewangan Antarabangsa/ *International Finance* 3(3+0)
 Prasyarat/ *Prerequisite*: FIN3101
 Kursus ini merangkumi pendedahan kepada pengurusan kewangan antarabangsa firma, teori dan kaedah yang bersesuaian. Penekanan juga diberikan dalam sistem pertukaran mata wang asing, derivatif matawang dan analisis risiko negara.
This course gives exposure to the firm's international financial management, theory and relevance techniques. Emphasize is given on the exchange rate system, currency derivatives and country risk analysis.
- FIN4104 Teknologi Kewangan/ *Financial Technology* 3(3+0)
 Prasyarat/ *Prerequisite*: FIN3101
 Kursus ini merangkumi evolusi teknologi kewangan berhubung kait dengan kecerdasan buatan. Tadbir urus serta peraturan sandboxes dan cabarannya turut diberi penekanan.
This course covers the evolution of financial technology in relation to artificial intelligence. Governance as well as the rules of sandboxes and its challenges are emphasised.
- FIN4203 Pengurusan Risiko/ *Risk Management* 3(3+0)
 Prasyarat/ *Prerequisite*: FIN3101
 Kursus ini merangkumi jenis risiko kewangan kepada individu dan perniagaan. Kaedah pengukuran dan pengurusan risiko juga diberi penekanan.
This course covers various financial risks to individuals and businesses. The measurements and management of risk are also emphasised.
- FIN4204 Dagangan Sekuriti dan Pengurusan Portfolio/ *Securities Trading and Portfolio Management* 3(3+0)
 Prasyarat/ *Prerequisite*: FIN3101
 Kursus ini merangkumi prinsip dan aplikasi analisis asas dalam dagangan sekuriti dan pengurusan portfolio. Strategi dalam dagangan sekuriti dan portfolio kewangan juga diberi penekanan.
This course covers principles and application of fundamental analysis in securities trading and portfolio management. Strategies in securities trading and portfolio management investment are also emphasised.

- FIN4301 Etika, Tadbir Urus dan Kelakuan Profesional/ *Ethics, Governance and Professional Conduct* 3(3+0)
 Prasyarat/ *Prerequisite*: Tiada/ *None*
 Kursus ini merangkumi teori, falsafah, isu-isu semasa berhubung dengan etika, tadbir urus dan tingkah laku profesional dalam persekitaran perniagaan dan industri kewangan. Dilema pembuatan keputusan kewangan juga diberi penekanan.
This course covers theories, philosophies, and current issues in relation to ethics, governance, and professional conduct in business environment and financial industry. The dilemma in financial decision-making is also emphasised.
- FIN4401 Ekonometrik Kewangan Gunaan/ *Applied Financial Econometrics* 3(3+0)
 Prasyarat/ *Prerequisite*: FIN3102
 Kursus ini merangkumi konsep dan kaedah dalam bidang ekonometrik. Perbandingan antara pelbagai model ekonometrik kewangan dalam analisis data kewangan ditekankan.
This course covers the concepts and methods in econometric. The comparison between variation of financial econometric models in financial data analysis is emphasised.
- FIN4402 Derivatif Kewangan/ *Financial Derivatives* 3(3+0)
 Prasyarat/ *Prerequisite*: FIN3102
 Kursus ini merangkumi teori, prinsip dan aplikasi derivatif kewangan. Ia juga membincangkan konsep perlindungan nilai, arbitraj, dan spekulasi.
This course covers theories, principles and application of financial derivatives. It also discusses the concepts of hedging, arbitrage, and speculation.
- FIN4403 Kejuruteraan Kewangan/ *Financial Engineering* 3(3+0)
 Prasyarat/ *Prerequisite*: FIN3103
 Kursus ini merangkumi konsep dan aplikasi kejuruteraan kewangan. Penggunaan derivatif produk dalam pengurusan risiko juga dibincangkan.
This course covers concept and application of financial engineering. The usage of derivative products for risk management is also discussed.
- FIN4404 Pemodelan Kewangan dan Data Analitik/ *Financial Modeling and Data Analytics* 3(3+0)
 Prasyarat/ *Prerequisite*: FIN3102
 Kursus ini merangkumi kaedah kuantitatif dan alat kewangan dalam penyelesaian masalah. Penggunaan perisian komputer dalam mereka bentuk model kewangan yang digunakan dalam pasaran kewangan ditekankan.
This course covers quantitative techniques and financial tools in problem solving. Application of computer software in designing financial models used in the financial market is emphasized.
- FIN4501 Pengurusan Kewangan Islam/ *Islamic Financial Management* 3(3+0)
 Prasyarat/ *Prerequisite*: FIN3101
 Kursus ini merangkumi teori, prinsip dan aplikasi kewangan dalam pembentukan sistem pengurusan kewangan Islam. Kursus ini juga menekankan kaedah pengiraan zakat menurut kaedah Islam.
This course covers theories, principles and application of Islamic finance in developing an Islamic financial management system. This course also emphasizes on the computation of zakat based on Islamic method.
- FIN4105 Pengurusan Bank/ *Bank Management* 3(3+0)
 Prasyarat/ *Prerequisite*: FIN3101
 Kursus ini merangkumi struktur, integriti peminjam, pembuatan keputusan pelaburan dan kewangan dalam sesebuah institusi kewangan dan sistem perbankan. Ianya menerangkan hubungkait yang rapat antara sistem perbankan dan pasaran kewangan Malaysia.
This course covers structure, borrower integrity, investment and financial decision making in a financial institution and the banking system. It explains the close relationship between banking and Malaysian financial system.

- FIN4205 Pelaburan Alternatif/ *Alternative Investment* 3(3+0)
 Prasyarat/ *Prerequisite*: FIN3103
 Kursus ini merangkumi kaedah pelaburan alternatif dan memberikan pengetahuan terperinci dalam memahami konsep strategi pelaburan alternatif. Prosedur dalam pembinaan portfolio diberi penekanan.
This course covers alternative investment tools and provides the knowledge in understanding the concept of hedge fund investment strategies. Procedures in portfolio construction are also emphasised.
- FIN4302 Perkhidmatan Kewangan Terkhusus/ *Specialised Financial Services* 3(3+0)
 Prasyarat/ *Prerequisite*: FIN3103
 Kursus ini merangkumi perkhidmatan kewangan yang ditawarkan oleh institusi kewangan. Teknologi kewangan dan proses pembiayaan turut diberi penekanan.
This course covers financial services offered by the financial institutions. Financial technology and financing process are emphasised.
- FIN4405 Sekuriti Pendapatan Tetap/ *Fixed Income Securities* 3(3+0)
 Prasyarat/ *Prerequisite*: FIN3103
 Kursus ini merangkumi pelbagai istilah pelaburan kewangan, teori dan pelbagai alat pengiraan kewangan bagi sekuriti pendapatan tetap. Aplikasi dan pengukuran setiap pelaburan kewangan juga ditekankan.
This course covers the variety of financial investment terms, theories and several financial computation tools for fixed income securities. The application and measurement of each financial investment also emphasised.
- FIN4901 Latihan Industri/ *Industrial Training* 3(3+0)
 Prasyarat/ *Prerequisite*: FIN3103, FIN4102, FIN4201 & FIN4301
 Kursus ini merangkumi pendedahan pelajar kepada persekitaran kerja sebenar di industri. Latihan meliputi aplikasi pengetahuan kewangan gunaan yang telah dipelajari dengan amalan semasa di tempat kerja. Kemahiran komunikasi, kerja berkumpulan dan menyelesaikan masalah secara beretika turut diberi penekanan.
This course covers students' exposure to the real work environment in the industry. The training covers the application of applied financial knowledge that has been learned with current practices in the workplace. Communication, teamwork and ethical problem-solving skills are also emphasized.
