KEYNOTE SPEAKERS

1. Prof Dr Daniel Meyer (University of Johannesburg, South Africa)

Daniel Meyer is appointed as a Full Professor, School of Public Management, Governance and Public Policy at University of Johannesburg, South Africa, specialising in regional and local economic development analysis as well as policy development. He has developed various measurement tools, indices and scales to analyse regional economies. Since 2015, he has authored more than 100 internationally peer-reviewed research papers, and has also presented more than 50 international conference papers, including a number of keynote addresses. His research is multi-disciplinary, covering development economics and public management and governance. He has since successfully supervised 10 PhD students and 13 master's degree students. He has developed a large international network of research partners across the globe with a strong focus on the Visegrad group of countries. Daniel has successfully completed and delivered more than 40 regional development strategies for local and provincial governments, and is also involved in various community development projects. Throughout his academic career, he has received a number of awards: most inspiring lecturer (2012); Vice-Chancellor's award for community engagement via the Vaal LED warrior initiative (2016); media person of the year (2016); most productive senior researcher on the NWU Vaal campus (2016, 2017, 2018); and most productive senior researcher in the NWU Faculty of Economic and Management Sciences (2019). His motto in life is "give more than you take".

2. Prof Dr Hooy Chee Wooi (University Sains Malaysia)

Hooy Chee Wooi, is a Professor at the School of Management, Universiti Sains Malaysia. He was born in Georgetown, Penang and has completed his secondary education in Chung Ling High School. He joined USM after obtaining his PhD from the University of Malaya in 2008. His research interest is in international finance, financial economics, and corporate governance. He has published in numerous ISI journals including Emerging Market Review, International Finance, Pacific Basin Finance Journal, The British Accounting Review, and The North America Journal of Economics and Finance. He has served as visiting scholar in the United States, Australia, Hong Kong, South Korea, Japan, and Taiwan, and is currently Vice President of the Malaysian Finance Association.

3. Dr. Halimahton Sa'diah Let

(Director of Productivity Development and Competitiveness, Malaysian Productivity Corporation)

Dr. Halimahton Sa'diah Let, was born in Perak, Malaysia. She obtained her Bachelor of Economics from University of Malaya (UM) in 1998, Master of Economics and Management and PhD of Economics from Universiti Putra Malaysia (UPM) in 2008 and 2020, respectively. She has served Malaysia Productivity Corporation (MPC) for 21 years, an agency under the Ministry of International Trade and Industry (MITI). She started her career in MPC and served in the Global Competitiveness Division. Currently, she is a Director of MPC under the Delivery Management Office (DMO), to coordinate, monitor and evaluate delivery efforts between industry and government. Her role is to oversee the

eleventh Productivity Nexus which was established in 2017 under Malaysia Productivity Blueprint (MPB). The Productivity Nexus is a one-stop platform which supports, assists, and guides businesses to increase productivity level, increase innovation, and capture growth opportunities. This platform is led by industry players and is fully supported and monitored by MPC.
